General Assignment:

Under direction of the Head Athletic Trainer, the Athletic Trainer performs a number of support functions to assist in the overall operation of the Athletic and Kinesiology Departments, with emphasis in Athletic Training. These responsibilities for the Athletic Department include, but are not limited to, assisting with home and away event coverage, sport team coverage and travel, treatment and rehabilitation of student-athletes, make necessary medical referrals, and assist in the determination of athletes' ability to compete. For the Department of Kinesiology, the intern will assist in the supervision of athletic training students in all aspects of therapeutic exercises and modalities, athletic training room operations, and preparation for the certification exam. The Athletic Trainer may also be responsible for teaching athletic training laboratory classes for the department. Motivated interns may pursue a Masters degree in conjunction with this internship. (Deadline to enroll in CSU, Fresno Graduate Program is April 1, 2008.)

Required Education, Experience, Knowledge, Skills and Abilities:

- Bachelor's degree from an accredited four-year institution by July 1, 2008
- Possession of a National Athletic Training Certification (NATA) by July 1, 2008
- Experience in athletic training with a variety of sports

- Ability to:

 - support the gender goals of the University
